

## Customer and Supplier Privacy Disclosure

Subject: Privacy disclosure pursuant to article 13 of EU Regulation no. 2016/679 (hereinafter, "GDPR")

The EU Regulation No. 2016/679 safeguards the privacy of personal data to protect the freedom and rights of data subjects and imposes a series of obligations on those who "process" personal information concerning other subjects. Among the most important obligations that the law requires to be respected is that of informing data subjects and obtaining their consent to the processing, especially for processing activities for which the data must be communicated to other parties.

Given the above, therefore, we inform you, pursuant to Article 13 of the GDPR in question, that the undersigned company collects and processes data concerning your company without your express consent (art. 24 letters a), b), c) Privacy Code and art. 6 letters b), e) GDPR) for purposes related to the management of ordinary commercial relationships, specifically for compiling registry lists, maintaining customer/supplier accounts, invoicing, and managing creditors to fulfill all obligations provided for by current regulations.

Your data may also be processed for internal purposes of statistics and market research only. The processing of your personal data is carried out through the operations indicated in Article 4 of the Privacy Code and Article 4 no. 2 GDPR, specifically: collection, recording, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, erasure, and destruction of data. Your personal data are subject to processing both in paper and electronic and/or automated form.

The Controller will process the data for the time necessary to fulfill the aforementioned purposes and in any case not beyond 10 years from the termination of the relationship for administrative/accounting purposes and not beyond 5 years from the data collection for marketing purposes. Processing may be carried out using both computerized and manual tools, observing all necessary precautions to ensure the security and confidentiality of the information.

Your data may also be communicated to third parties, exclusively for technical and operational needs strictly related to the aforementioned purposes, and in particular to the following categories of subjects:

- a) entities, professionals, companies, or other structures appointed by us for processing related to the fulfillment of administrative, accounting, and management obligations linked to the ordinary conduct of our economic activity, including credit recovery purposes;
- b) public authorities and administrations for purposes related to the fulfillment of legal obligations;
- c) banks, financial institutions, or other subjects to which the transfer of such data is necessary for the performance of our company's activities in relation to the fulfillment, by us, of contractual obligations undertaken towards you.

As an interested party, you have the rights provided for in Article 7 of the Privacy Code and Article 15 GDPR, namely the rights to:

- i. obtain confirmation of the existence or otherwise of personal data concerning you, even if not yet recorded, and their communication in an intelligible form:
- ii. obtain indication of: a) the origin of personal data; b) the purposes and methods of processing; c) the logic applied in case of processing carried out with the aid of electronic instruments; d) the identification details of the data controller, data processors, and the designated representative pursuant to Article 5(2) of the Privacy Code and Article 3(1) GDPR; e) the subjects or categories of subjects to whom the personal data may be communicated or who may become aware of it in their capacity as designated representatives in the territory of the State, data processors, or persons in charge;
- iii. obtain: a) updating, rectification, or, when interested, integration of data; b) erasure, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed; c) certification that the operations referred to in letters a) and b) have been notified, also as regards their contents, to those to whom the data were communicated or disseminated, except where such fulfillment proves impossible or involves a manifestly disproportionate effort compared with the right being protected;
- iv. object, in whole or in part: a) on legitimate grounds, to the processing of personal data concerning you, even if pertinent to the purpose of the collection; b) to the processing of personal data concerning you for the purpose of sending advertising materials or direct selling or for the performance of market research or commercial communication, using automated calling systems without the intervention of an operator, by email and/or traditional marketing methods via telephone and/or postal mail. It is noted that the data subject's right to object, as stated in the previous point b), to direct marketing purposes using automated means extends to traditional means, and that the data subject may nevertheless exercise the right to object in part only. Therefore, the data subject may decide to receive only communications via traditional methods or only automated communications, or neither of the two types of communication.

Where applicable, you also have the rights provided for in Articles 16-21 GDPR (Right to rectification, right to erasure, right to restriction of processing, right to data portability, right to object), as well as the right to lodge a complaint with the Italian Supervisory Authority
